

Among others, winner of the IDEE 154th German Derby (Gr.1), Großer Preis von Wettstar (Gr.2), 154th Großer Preis von Baden (Gr.1), Qatar Prix Niel (Gr.2), Japan Racing Association – Derby Trial (Gr.3), Preis des Winterfavoriten (Gr.3). Official German rating (GAG): 100.5 kg. Standing at Gestüt Ebbesloh.

PALLADIUM

by Gleneagles out of Path Wind – Breeder: Stiftung Gestüt Fährhof – purchased at the BBAG Yearling Sale for €80,000 – was in training with Henk Grewe in Cologne. Among others, winner of the IDEE 155th German Derby (Gr.1). Official German rating (GAG): 97.5 kg – sold at the Arqana Arc Sale for €1.4 million to Lady Bamford.

ASSISTENT

by Sea the Moon out of Anna Kalla – Breeder:
Gestüt Röttgen – purchased at the BBAG Yearling
Sale for €58,000 – was in training with Henk Grewe
in Cologne. Among others, winner in Carl Jaspers
Preis (Gr.2), Hansa-Preis (Gr.2), Großer Preis von
Meravis (LR), Grand Prix Aufgalopp (LR), finished
4th in IDEE 153rd German Derby (Gr.1). Official
German rating (GAG): 98.5 kg.Private sale to Eckhard Sauren for whom he went on to win several
races, among them the Großer Allianz Preis von
Bayern (Gr.1). Standing at Gestüt Röttgen.

WINNING SPIRIT

von Soldier Hollow out of Wamika – Breeder: Gestüt Park Wiedingen – purchased at the BBAG Yearling Sale for €80.000 € – was in training with Peter Schiergen in Cologne. Among others, winner in the Premio Campobello (LR), Premio Emanuele Filiberto (LR), 2nd in 140th Derby Italiano (Gr.2), 3rd in Herzog von Ratibor-Rennen (Gr.2), 4th in IDEE 154th German Derby (Gr.1). Official German rating (GAG): 92 kg – sold at the Arqana Arc Sale for €430,000.







THE APPROACH

After several successful syndicates, we have summarised our joint strategy at LIBERTY RACING as follows:

- Professional selection of top-quality horses by an experienced and well-connected team of experts across all relevant areas (rearing, conformation, pedigree, veterinary care, and training).
- In the selection of horses, the main focus is on successful German bloodlines and proven sires, with
 a clear emphasis on classic potential especially
 for the German Derby (Deutsches Derby) and Oaks
 (Preis der Diana).
 - LIBERTY RACING 2025 Platinum: Primarily from proven sires. However, the fourth horse may be by an unproven sire if conformation and pedigree are exceptional, and the market lacks affordable yearlings by proven sires.
 - **LIBERTY RACING 2025 GOLD:** Yearlings by unproven sires may also be considered here, with a stronger focus on physical conformation.
- When selecting horses, we use the latest IT technology and proven successful applications (such as equineline.com, thoroughbreddailynews.com or g1goldmine.com) and consult successful
- trainers and very successful auction buyers in addition to the existing team. The process begins long before the auction – by visiting stud farms and closely analysing pedigrees. Our in-depth knowledge of successful thoroughbred families, built over years, is key to the syndicate's success.
- Pre-training by experienced professionals and training by top-level trainers.

- Professional management guarantees careful selection and development of horses.
- Lower risk of loss compared to buying a horse as individual owner - one single payment generates shares of several horses.
- Using the strength of German breeding (especially stamina) and its globally successful dam lines through targeted purchases.
- International network and experience to support potential resale and success abroad.
- Shared racing experience at the racecourse, during morning workouts, and through stud visits.
- New syndicates launched every year.
- Premium events for syndicate members, combining leisure activities and education at the highest level (including introductory talks on thoroughbred ownership and racing).
- Not an investment product.
- All decisions and services for LIBERTY RACING are handled by LIBERTY RACING Management UG.
- All syndicate members understand that, even with multiple horses, there is still a risk of total financial loss. Thoroughbred racing syndicates are a form of passion and high-end leisure – not an investment vehicle.



LIBERTY RACING 2025 - SYNDICATES AT A GLANCE

In 2025, the classic syndicate model will return: LIBERTY RACING 2025 PLATINUM will offer 24 to 33 shares, each priced at €27,500.

If this syndicate sells out quickly and demand remains high, we will once again offer an entry-level option: LIBERTY RACING 2025 GOLD. Here, each share is priced at €13,500, with 28 to 32 shares available, and three horses will be purchased for the syndicate.

Selection criteria:	Both proven and freshmen sires may be considered for selection, with a continued focus on the horses' classic potential for the German Derby (Deutsches Derby) and the German Oaks (Preis der Diana). The key criteria remain conformation, pedigree and overall impression. Selection process as in previous years (IT tools supporting pedigree analysis, yearlings are viewed in person both at the stud farms and during the auction, and all purchases must be unanimously approved by a five-member expert team.)
Sales/Dissolution:	Horses are sold at the end of the three- year-old season. One horse can be kept after a majority vote for another year. Settlement takes place on Dec 31, 2027. All proceeds and profits achieved after deduction of all costs (purchase, training, veterinary, etc.) are paid out to the shareholders.shareholders.

THE COSTS

Depending on the syndicate, the cost per share varies. In LIBERTY RACING 2025 PLATINUM, each share is priced at €27,500. Should LIBERTY RACING 2025 GOLD be launched, the cost per share will be €13,500.All syndicates will concluded and fully settled as of 31 December 2027.

Each shareholder will receive their proportional share of the available funds (net prize money and net proceeds from any horse sales), after deduction of all costs, including purchase price, training fees, veterinary expenses, and so on.

It is possible to acquire multiple shares.

LIBERTY RACING Management UG receives a 5 percent management fee per syndicate share upon purchase, 5 percent of all prize money earned by any horse within the syndicate, and 5 percent of the sale price from each horse sale when a syndicate is dissolved.

Should LIBERTY RACING Management UG generate a profit after deduction of all costs, these funds will be reinvested into the promotion of future syndicates and the broader popularisation of thoroughbred racing.

All additional costs, such as the purchase price of horses, auction fees, veterinary expenses, agent commissions, training fees, transport, racing colours, and other associated costs, are covered by the respective LIBERTY RACING 2025 syndicates using the capital contributed by their shareholders.

Once a share has been paid for, all costs are fully covered through to the conclusion of the syndicate. Payment is due within 14 days of confirmation and must be made to the designated account of the respective LIBERTY RACING 2025 syndicate. There is no obligation for additional payments beyond the original investment for syndicate shareholders.



THE FOUNDERS

Lars-Wilhelm Baumgarten and Nadine Siepmann are the founders of LIBERTY RACING, and both have been passionate enthusiasts of thoroughbred racing since childhood. The breeding of successful thoroughbreds and the purchase of exceptional racehorses are lifelong passions for them both. DJANGO FREEMAN – purchased on the basis of €80,000 prior to first start - group winner, 2nd in IDEE 150th German Derby – sold to Australia – Official German rating (GAG): 95.5 kg.

BE MY SHERRIF – 2-time Group winner (Carl Jaspers-Preis, Gr.2 and Fürstenberg-Rennen, Gr.3) – Official German rating (GAG): 96.5 kg.

KALIFORNIA QUEEN – Bred jointly with Nick Proschwitz – €60,000 purchase at the BBAG Auction Sale – Gr.2 winner in the 2020 German Oaks trial at Hoppegarten – Official German rating (GAG): 93 kg.

KALDERA – €11,000 BBAG purchase – classic winner in the German St. Leger Gr.3) – Champion Mare – Official German rating (GAG): 94 kg.
